

The undersigned is directed to forward herewith DoPT's Office Memorandum No.e-F.No.13/3/2023-IR-I dated 7th November, 2023 along with a copy of Order dated 09.10.2023 passed by the Hon'ble Supreme Court of India on the above subject. The Hon'ble Supreme Court directed that all Central and State Ministries shall take steps within a period of one month from the date of its Order to compile the email addresses of the Central and State Public Information Officers which shall be furnished to the Central Information Commission (CIC) and to all the State Information Commissions (SICs), as the case may be.
